Groundwater flood warnings

Over the last year and half, we have been busy rolling out a new groundwater flood warning service throughout Wessex. During 2013-14, Dorset and Wiltshire saw some of the worst groundwater flooding in 10 years. This period of abnormally high rainfall resulted in the inundation of low lying areas and the emergence of groundwater, causing damage to property and infrastructure. The impact of groundwater levels across the chalk in Wessex 2013-14, supported the need to warn and inform the communities of the potential risk of groundwater flooding.

We are always seeking to improve this service and ask if you could monitor the groundwater activity in your town or parish, things such as springs appearing or households pumping may give us an indication of changes in the groundwater. Additionally any historical information that is held by the town, parish council or individuals would be greatly appreciated.
